GUEST SERVICES STRIVES TO BREAK THE CYCLE OF POVERTY AND HOMELESSNESS THROUGH COMPREHENSIVE CASE MANAGEMENT SERVICES AND PROGRAMS GEARED TO ADDRESS COMMON ROOT FACTORS OF HOMELESSNESS.
